Abstract

Presenters of papers should send an abstract of not less than 200 and not more than 250 words in English, typed in New times Roma , font size 12, spacing 1.5, margins 1 inch all sides, saved in compatible mode (97 or 2003) and should be received by **17th July 2017** through the email; info@impromes.org or nyonjer@gmail.com . The abstract should highlight key areas of the study and should include objectives, methodology, findings and conclusions. It has to include the Title, Author's name (s), affiliation institutions, email address (es), phone numbers, and sub-them of the paper.

FULL PAPER

The full paper for accepted abstract should be submitted by **15th August 2017**. The full paper should be between 3,000 to 5,000 words in the same form as the abstract. You are required to attach a not more than 14 slide PowerPoint

Empirical paper: Title (15 words); abstract (250 words), key words (maximum 8), introduction, methods/material, results, discussion, conclusions and recommendations, references.

Theoretical Paper/Reviewed paper: Title (15 words); abstract (250 words), key words (maximum 8), introduction, literature review, theoretical analysis, application, conclusions, references.

Referencing: use APA styles 6th Edition, no footnotes and in-text citations in the abstract

CONFERENCE PRODUCTS: Reviewed papers will be published in a book as conference proceedings and the best paper will be considered for published in the IPromES Journal or International Journal for

Transformative Development Research (IJTDR). The best presenter in each category will be awarded a certificate of excellence; and all participants will be awarded certificates of participation

CONFERENCE FEE: (The Fee will cover conference facilities and equipment, materials, mid-morning tea and lunch. This does NOT include Accommodation, dinner or travelling expenses including excursion during the conference. Individual participants may make their own arrangements for accommodation
